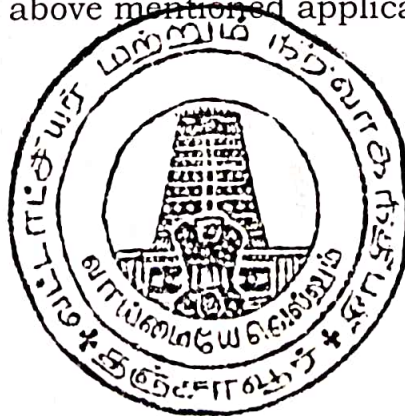

1. The period of validity of the New Public Building Licence shall be from **01.11.2022 to 31.10.2025** (inclusive of both days.)

2. There should be no additions or alteration in the existing building without getting prior permission from the competent authority. A fresh licence has to be obtained from the competent authority if any addition or alteration is proposed to be made to the existing building or a portion of building for which the licence has been granted.

3. A Licence shall be renewed from time to time by submitting application along with required supporting documents with the competent authority well in advance preferably before 3 months from the date of expiry of the existing licence .

4. This licence is liable to be suspended for any violation of the Act or Rules framed thereunder or the conditions of this licence or if the licensed premises are not found conforming to the description shown in the attached plans and Annexures with the above mentioned application.
