Sir/Madam,

This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

The school is directed to ensure that :

1.	The total number of section of the school after upgradation, shall be restricted to 13 (As per prescribed dimension) out of which, not more than 1/3rd sections may be used to run Senior Secondary classes and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2	The total number of section of the school shall be restricted to 13 (as per prescribed dimension) as per number of classrooms reported at the time of Inspection. The size of 4 classrooms are less than 500 sq ft. hence the school is directed to maintain student intake proportionately as per Affiliation Bye Laws. The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed. Further, increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per Affiliation Bye Laws and subject to the availability of room size of greater than 500 sq ft.
3	The school has created CWSN toilets but except for the girls toilet on 1st floor all others are too small with no room for a wheelchair/walker to navigate. The school shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage, indicating the floor number, as per norms of RPwD Act and guidelines issued by the Board and submit compliance within 3 months on SARAS.
4	All the 3 science labs for senior secondary classes are under equipped.The biology lab does not have work stations with proper utilities.The school shall upgrade the 3 labs as per SoP of the Board and submit compliance within 3 months.

5	The school library is seen as under sized and under stocked.No reading area for teachers is seen.The school does not have well developed indoor and outdoor sports facilities.The school shall upgrade its library and sports facilities as per SoP of the Board and submit compliance within 3 months on SARAS.
6	The school shall get all the mandatory certificates renewed periodically.
7	The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.
8	The school shall get training of its teachers done with CoE Chennai within 3 months and submit compliance on SARAS.
9	The school shall follow all the SoPs of the Board for its labs, library and sports facilities.

The above sanction is subject to fulfillment of following conditions:-

- The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
- The school to renew mandatory certificates from time to time.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
